KERALA STATE ELECTRICITY BOARD LIMITED, invites competitive bids from domestic bidders for Appointment of EPC contractor for the design as per site conditions, erection, testing & commissioning of Grid Tied Rooftop Solar Photo Voltaic (SPV) Power plants, on the Roof of buildings owned by **LSGD-Malabar** Viz Kannur District Panchayath, Perambra Block Panchayath and Chengalayi Grama Panchayath with a total installed capacity of 385 kWp in total 21 locations including Operation & Maintenance of the plant for the first 5 years from the date of handing over.

Only INTERNET BANKING remittance is allowed through e-payment facility provided by the e-procurement system. No other mode of payment is allowed. (Bidder should ensure that tender cost including GST and EMD are remitted as one single transaction and not separate. Separate or split remittance will be treated as invalid transactions).

Bidders are advised to visit the **"Downloads"** section of the website **www.etenders.kerala.gov.in** also. The NEFT facility for online payment may be exercised at least 48 hours before the closing date of the bid to ensure that payment towards tender document fee and EMD are credited and a confirmation is reflected in the e-procurement system.

All the Tender documents are to be submitted online only and in the designated covers on the above website and no manual submission will be entertained. The pre-qualification/technical bid shall be opened online at the office of the Chief Engineer (Renewable Energy & Energy Savings), 9th Floor, Vydyuthi Bhavanam, Pattom, Thiruvananthapuram on the date and time mentioned above in the presence of the bidders/ their representatives who wish to attend. All other existing conditions related to the tenders of KSEBL will be applicable to this tender also. The tender details will also be available in the KSEBL website '**www.kseb.in**'.

The bid shall be valid for 90 days reckoned from the date of opening of bid. No queries will be entertained after the pre bid meeting. There will be no negotiation of price once the bid is submitted and the price shall be firm. No correspondence would be made with the bidders once the bid is submitted. The bidder shall visit the site before submitting the bid preferably before the pre bid meeting. The decision taken in the PQ Committee will be final.

The bidding authority reserves the right to modify/cancel any or all bids without assigning any reasons. KSEBL will not be responsible for any errors like missing of schedule data while downloading by the bidder/ non receipt of document/delay if any.
