Earnest Money Deposit = [INR 11,58,000 x Rated cumulative Installed Capacity of Solar component (MW) as quoted by bidder + INR 13,86,000 x Rated cumulative Installed capacity of Wind component (MW) as quoted by the bidder + INR 4,80,000 x Rated cumulative Installed Capacity of the ESS component (MWh) as quoted by the bidder].

ANY BID NOT ACCOMPANIED BY AN ACCEPTABLE BID SECURITY IN A SEPARATE SEALED ENVELOPE SHALL BE REJECTED BY THE EMPLOYER AS BEING NON-RESPONSIVE AND SHALL NOT BE OPENED.

4.0 MSEs (Micro and Small Enterprises) having UDYAM registration only are exempted from submission of Cost of RfS Document, Processing Fee & Earnest Money Deposit (EMD). For a Consortium to be eligible for exemption from submission of Cost of RfS document, Processing Fee & Earnest Money Deposit, all the members of the Consortium shall be registered as MSE.

- 8.0 Issuance of RfS Documents to any Bidder shall not construe that such Bidder is considered to be qualified. Bids shall be submitted online. Bidder shall furnish Earnest Money Deposit, Pass Phrases, Board Resolution and other documents separately offline as detailed in RfS Documents before the stipulated bid submission closing date and time at the address given below.
- 9.0 Transfer of RfS Documents purchased by one intending Bidder to another is not permissible.
- 10.0 Any 'Bidder from a country which shares a land border with India', as specified in the Bidding Documents, will be eligible to bid in this tender only if bidder is registered with the Competent Authority as mentioned in the Bidding Documents.
